The COVID-19 pandemic raises questions of global justice and solidarity with an even stronger sense of urgency. While in Germany a debate is unfolding on how to take back restrictions for vaccinated people, many countries in the Global South do not have anywhere near enough vaccines - for example, less than 2% of the African population have been vaccinated so far.

This is a stark contrast to many statements by politicians from wealthier nations, who emphasise the importance of solidarity in the global fight against the pandemic. Is this just lip service? We will explore this question in detail at our **sef**: **Policy Lunch** on 18 May 2021. In addition, our latest **Global Governance Spotlight** deals with solidarity in global health cooperation.

Global Governance Spotlight 2 2021


